S.S. COSMAS AND DAMIAN

S.S. Cosmas & Damian Catholic School (SSCD) is located in Punxsutawney, Pennsylvania. The school was built in 1892 and by January of 1893 had an enrollment of 116 students. Today there are 143 students attending SSCD in pre-school through eighth grade.

The mission of S.S. Cosmas and Damian School is to educate the whole child: spiritually, intellectually, physically, emotionally and socially through classroom instruction, religious formation, and personal example. The faculty and staff are dedicated to Christian education in a Catholic tradition, they strive to provide this through professional competence and development in a faith-centered environment that is nurturing and affirming. Their goal is to enable students to become Christ-like.

Mrs. Ann Smith has been the principal for twenty four years, she also teaches Social Studies to grades 6 through 8. Including Mrs. Smith there are fourteen teachers at SSCD. The school has earned its Middle States Accreditation and is currently working on its most recent evaluation.

SSCD offers technology to all students and Spanish is offered to students in grades K-8. Extra-curricular activities include; boys and girls basketball, band, chorus and an after-school homework program.

Last summer Msgr. Riccardo, pastor of S.S. Cosmas & Damian, purchased 20 laptops computers for the technology lab and had wireless internet installed making it available for students in the lab as well as other areas of building. Msgr. also purchased several 42" televisions; one for each classroom. Teachers use the televisions in conjunction with their lessons, and the 8th grade students use them for daily announcements and as a venue for praying together as a school each morning.

SSCD Food Drive

This summer plans have been made to provide an on-site playground for the students of SSCD and children in the neighborhood. The playground project will be funded by a grant from the PA Department of Economic & Community Development.

The parish has just completed an addition of a gathering space in the church. Next year will be the 125th anniversary of the parish and the renovations were done in conjunction with that celebration. The children attend a student Mass in the Church weekly and have enjoyed seeing the transformation of the interior.

When asked about SSCD's experience with The Children's Scholarship Fund of PA, Mrs. Smith said, "Our involvement with the Children's Scholarship Fund has truly been an asset to our families and our school. For those who truly appreciate the value of a Catholic education and cannot afford it without financial assistance, the scholarship fund has been a real blessing." Mrs. Smith added, "I feel that it is so easy for our parents to fill out the applications. I am very well satisfied with how The Children's Scholarship Fund interacts with S. S. Cosmas and Damian."

Msgr. Riccardo also added, "I became familiar with the Children Scholarship Fund while at Immaculate Conception Church, in Clarion, PA as they were forming their organization. It had high hopes in the beginning with the new legislation in Pennsylvania, becoming the first organization in Pennsylvania to be certified to receive from various businesses and distribute funds to schools. The Children Scholarship Fund has grown each year in contributions and in schools affected by their fund distribution. I was happy to have S.S. Cosmas and Damian included on their list of schools. The scholarships have helped a number of our parents who otherwise would find it hard to send their children to our school. I continue to admire the work they began and continue to do for the parents and children in the schools of the Catholic Diocese of Erie."

Important dates for businesses to remember:

May 15th—Applications for second year businesses are being accepted at the DCED

July 1—Applications for first year businesses (other than those claiming PIT) are being accepted at the DCED

July 8—Applications for businesses claiming PIT are being accepted at the DCED

Act 4 of 2001 & ACT 48 of 2003 of the Education Improvement Tax Credit Program

\$8,000,000 set aside for Pre Kindergarten Scholarships

- ◆ Businesses will receive a 100% credit for the first \$10,000, and up to a 90% credit on the remaining amount of the contribution.
- ◆ Requires only a 1 year commitment!
- ◆ Businesses can apply for up to a \$150,000 in credits.
- ◆ The school must be within the Commonwealth of Pennsylvania.

\$67 Million set aside for K through 12 Scholarships

- ◆ \$44.7 Million to Educational Improvement Organizations
- ◆ Businesses can increase their Credit to \$300,000 per fiscal year for the K through 12 program.
- ◆ 1 or 2 year commitment
- ◆ The school must be within the Commonwealth of Pennsylvania.
